With reference to our earlier intimation dated September 9, 2025, we wish to inform you that WAARERTL has received a Letter of Award for a revised project capacity of 704 MWac / 1,000 MWp. This revision is pursuant to evacuation considerations and optimization of DC overloading and will result in a proportionate reduction in the contract value.

Except for the above reduction in capacity and the corresponding contract value, all other terms, conditions, scope of work, and pricing structure of the Work Order remain unchanged and continue to be in full force and effect.
